

Declaration on the REACH Regulation

European Community Regulation on Chemicals REACH - Registration, Evaluation, Authorisation and Restriction of Chemicals

On June 1st 2007, regulation (EC) No. 1907/2006 (REACH) has entered into force. Until the first phase-in deadline of December 1st 2010 all substances with a yearly volume of \geq 1000 tons had to be registered at the European chemicals Agency ECHA in Helsinki.

Until the second phase-in deadline of June 1st 2013 all substances with a yearly volume of \geq 100 Tons had to be registered.

Until the third phase-in deadline of June 2018 all substances and mixtures with a yearly volume of ≥ 1 Ton have to be registered.

Symalit AG is a downstream user and only manufactures articles which do not intentionally release chemical substances. Registration therefore is not required.

Nevertheless, Symalit AG implements the REACH regulation, also in keeping the interest of the customers in mind. Thus, we ask our suppliers to register products, which fall under the REACH regulation, including their uses, or to pass this requirement onto their sub-suppliers. This supplier requirement is included in the relevant Symalit AG documents.

The products manufactured by Symalit AG including their packaging materials do not contain any SVHC (substances of very high concern), which appear on the candidate list or on the list of substances subject to authorisation according to annex XIV of the REACH regulation, published by the creation date of this letter. In case one of our products or packaging materials contains SVHC, recently added to the candidate list, Symalit AG will immediately inform the customers concerned.

The Symalit AG products are articles. Safety datasheets according to article 31 of the REACH regulation are not required. However Symalit AG provides information to ensure safe use of their products on request.

On the basis of the above mentioned procedure, Symalit AG declares to exclusively deliver products into the European Community which comply with the REACH regulation.
